Hello everyone!

- As our Board Member for Minodahmun Development LP, it's great to announce that we have new training dollars to offer 100 training programs spots this coming year for the members of AZA, Aroland and Ginoogaming to prepare for employment opportunities with Greenstone Gold Mines. The details are being finalized and more information will be coming out very soon on which programs will be offered as well as their start dates. Mason will be sharing information on the programs as they become available. This new funding will also allow us to hire some additional support staff and we will be recruiting for these new positions soon. As the recruitment process will occur between our April and May newsletters, I wanted to share this early information here. If you are interested in either of the 2 new positions below, please let me know and I can share the job postings as soon as they come available. These postings will also be uploaded to our website when ready.
- New jobs becoming available to support the Minodahmun training program include: a Program Coordinator to work for Minodahmun Development LP to help manage the training program with our communities, trainees, funders and Confederation College.
 - A Student Success Advisor to work for our First Nation to help support our members apply for training and to support them through the program.
- Through AETS, there are 2 programs currently open for applications. The first is a Food Service Worker training program accepting applications until April 5th and the second is the Drywall, Acoustics and Lathing Pre-Apprenticeship course which is still accepting applications until June 2nd. More information on both of these programs can be found at www.aets.org or contact me if you want more information.
- AETS has also secured a new pot of funding to develop training programs over 2021 and 2022 and details of these new programs will be released soon. As we slowly move out of the Covid pandemic, Governments are funding training programs more than ever. This coming year will bring a lot of new training opportunities to help interested members become ready for the Greenstone Gold Mines project as well as other employment opportunities. ROAD PROJECT

The road project will be done in two phases. First phase will be hauling and stockpiling granular. The second phase will be the road upgrade to the residential area and two streets.

This project is pending on funding approval from ISC. Hoping to get some of the "slush" funds left over at the end of the fiscal year to do the granular. Phase two application has also been submitted and awaiting approval on that as well.

PROPOSALS

I have been working on a couple proposals that will, if approved, bring some employment and development to Lake Nipigon Reserve.

Hoping to get my brush cutting crew back to work this summer.

HOUSING

An Expression of Interest has been submitted for 10 houses. This is the first step in applying for a housing project.

If we score high enough, we will then submit a more detailed application with blueprints and contractor to build the houses.

If everything goes well, we could start on the foundations this fall and continue the project next spring. We will have two years to complete the project.

This housing project will be CMHC Section 95 (rent to own). Surveys will be sent out to determine who is interested in moving to the Reserve and what type and size of house our members need.

Animbiigoo Zaagi'igan Anishinaabek became a signatory to the Framework Agreement on First Nations Land Management on April 20th,2017. This means we agree to develop a Land Code, Community Ratification Process, and negotiate an Individual Agreement. Animbiigoo Zaagi'igan Anishinaabek Members will ratify the Framework Agreement by voting on the Land Code and Individual Agreement.

What's been done?

Three major processes:

Completed the draft of the Animbiigoo Zaagi'igan Anishinaabek Land Code was review by lawyer, summitted and approved by Verifier March 14th,2021.

The land description and boundary survey of Animbiigoo Zaagi'igan Anishinaabek that will govern and manage if the Land Code is passed by the membership.

The Phase 1 ESA process — Phase 1 ESA was completed March 2019 by DST Consulting Engineers. The purpose of this process is to prioritize contaminated areas for Canada to clean-up in the future.

What is an Individual Agreement? What is the Community Ratification Process?

Under 6.1 of the Framework Agreement, the Minister and each First Nation that intends to manage its First Nation land will also enter into an Individual Agreement to settle the actual level of operational funding for the First Nation and the specifics of the transfer of administration between the First Nation and Canada. To ensure the membership is fully informed of the process of approving the Land Code and Individual Agreement.

A Community Ratification Process (CRP) has to be developed, review and approved by the Verifier March 14th,2021. It sets out the procedure by which the community will decide whether to approve its Land Code and the Individual Agreement, specifically, how the community vote will be organized, the voting process, and how it will be monitored and verified by a third party.


